Important Questions	Answers	Why This Matters:
What is the overall deductible ?	Per calendar year: Participating Providers \$1,000/individual.	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay.
What is the Family deductible Savings Provision?	If three (3) or more qualified family members enroll in individual Pool Policies with the same deductible amount, then reduced deductible limits may apply.	The entire Family meets an annual deductible when the total deductible amount for all family members reaches two times the individual deductible amount chosen. Note: If an Enrollee's individual deductible is met, no more charges incurred by that Enrollee may be used to satisfy the Family Deductible.
Are there services covered before you meet your deductible ?	Yes. Network copayments , network preventive care , non-intensive mental health & substance abuse outpatient treatments, and prescription drugs are covered before you meet your deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . Are there other deductibles for specific services?	No. There are no other specific deductibles .	You don't have to meet deductibles for specific services.
What is the out-of-pocket limit for this plan ?	Per calendar year: Participating Providers \$5,000/individual.	The out-of-pocket limit is the most you could pay in a year for covered services.
What is the Family out-of-pocket Savings Provision?	If three (3) or more qualified family members enroll for Pool Policies with the same out-of-pocket amount, then reduced out-of-pocket limits may apply.	The entire Family meets an annual out-of-pocket limit when the total out-of-pocket amount for all family members reaches two times the individual out-of-pocket limit. Note: If an Enrollee's individual out-of-pocket limit is met, no more charges incurred by that Enrollee may be used to satisfy the Family out-of-pocket .
What is not included in the out-of-pocket limit ?	Premiums , balance-billing charges, and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .

If you receive services from an out-of-network facility, you may receive a bill from the facility for the difference between the facility charge and what your plan pays (balance billing).</u> Be aware, your participating provider might use a non-participating provider for some services (such as lab work). Does this plan provide Minimum Essential Coverage? Yes.

If you don't have [Minimum Essential Coverage](#) for a month, you'll have to make a payment when you file your tax return unless you qualify for an exemption from the requirement that you have health coverage for that month.

Does this plan meet Minimum Value Standards? Yes.

If your [plan](#) doesn't meet the [Minimum Value Standards](#), you may be eligible for a [premium tax credit](#) to help you pay for a [plan](#) through the [Marketplace](#).

About these Coverage Examples:



This is not a cost estimator. Treatments shown are just examples of how this [plan](#) might cover medical care. Your actual costs will be different depending on the actual care you receive, the prices your [providers](#) charge, and many other factors. Focus on the [cost sharing](#) amounts ([deductibles](#), [copayments](#) and [coinsurance](#)) and [excluded services](#) under the [plan](#). Peg is Having a Baby
(9 months of in-network pre-natal care and a hospital delivery)

- Prescription drugs
- Durable medical equipment (*glucose meter*)
